2010 TUITION

Please enroll my child for the 2010 camp season. I agree to pay \$2,750 with this agreement which will be credited towards the camp tuition of \$9,500. An additional \$200 Activity fee shall be added to campers under 5th grade; \$300 Activity/Extended Trip fee shall be added to the 5th & 6th grade groups; \$400 shall be added to the groups 7th grade through 9th grade; and \$425 shall be added to 10th grade campers.

The remaining payments shall be as follows: \$ 2,500 due by November 1, 2009. \$ 2,500 due by January 15, 2010. Balance due by March 15, 2010.

New for 2010 - We have added the following payment options:

- Early Enrollment Credit** - (\$275 tuition credit) Enrollments must be received by August 12th along with a \$2,750 deposit. For your convenience, checks, Visa, MasterCard and American Express are accepted.
- Automatic Monthly Payment Credit** (additional \$100 tuition credit) Enrollment must be received by August 12th along with a \$2,750 credit card deposit. We will then charge \$975 to your credit card on the 15th of each month (September 15th - February 15th), with the remaining balance to be charged on March 15th. Please note that the \$100 Automatic Monthly Payment Credit will be applied to the final balance on March 15th provided that all of the monthly payments have been made.

RULES AND REGULATIONS

This agreement is subject to and includes the following conditions:

1. Your child must be examined by your physician and dentist. Your medical form **MUST** be submitted to the camp office prior to your child's departure to camp.
2. The camper and his/her parents agree to abide by the rules and regulations set by the Directors for the health, safety and welfare of the camp and its campers and staff.
3. The Directors reserve the right to send home a camper whose physical condition, conduct or influence is deemed unsatisfactory or inimical to the best interests of the camp.
4. No reduction or allowance is made for the late arrival of a camper.
5. No reduction or allowance is made for the early withdrawal of a camper.
6. Program is subject to change without prior notice.
7. In the event of any emergency in which the parent cannot be contacted, the Directors reserve the right and are hereby authorized to have the camper hospitalized, or to use outside medical, surgical, or dental aid. All such expenses shall be paid by the parent, if not otherwise covered by the camp's Health & Accident Insurance Policy. It is important that you keep Trail's End Camp informed of your summer address and cell phone number(s).
8. We suggest that you consult your insurance agent to make sure that your child's equipment and personal belongings are covered while in transit or at camp. The camp is not responsible for such loss or damage by fire, theft, laundry, etc.
9. Acceptance and execution of agreement will be completed upon acknowledgement of receipt of your payment by Trail's End Camp. All jurisdictions waived except Pennsylvania.
10. This is the entire agreement. There are no other terms or agreements that are not contained herein.
11. No change to this agreement may be made unless in writing and signed on behalf of TRAIL'S END CAMP by the president of R.R.S.C., Inc.
12. I understand that part of the camping experience involves activities, group living arrangements and interactions that may be new to my child. These things come with certain risks and uncertainties beyond what my child may be used to dealing with at home. I am aware of these risks, and I am assuming them on behalf of my child. I realize that no environment is risk-free and so I have instructed my child on the importance of abiding by the camp's rules. My child and I both agree that he or she is familiar with these rules and will obey them.
